

CURSILLO SECRETARIAT MEETING

June 22, 2022

- **THOSE IN ATTENDANCE:** Roseann Guerrini, Lay Director; Chairpersons in attendance: Roberta Davis, Richard Druffner, Dave Marazzo, Ann Marie Segilia, Tina Stryker, Wendy Vogt. Committee Members in attendance: Bill Benning and Terri DiBacco.
- **NEW BUSINESS:**
 - Elections will be held for Chair for School of Leaders and Chair of Post opinions and
 - Roseann Guerrini expressed her concerns with the need for unity, when we are voting, and the needed to be guided through prayer.
 - Dave Marazzo brought up concerns regarding the parameters used for the 3 nominees for the Post Cursillo Chair. He felt we should wait until 2 of the candidates meet the requirements in the By-laws saying that you must have worked a weekend to be on Secretariat.
 - The Election Committee explained why we had made exceptions to these requirements. The two had not had an opportunity to work on a weekend team due to Covid, and both were on the Weekend team for the upcoming weekends.
 - Dave Marazzo said he also learned that there was a problem with one of the applications since it was submitted 5 days after the deadline.
 - The Election Committee explained that since there were other exceptions being made, there was no reason to not accept the late application.
 - Dave Marrazzo put forth a motion to disqualify all nominated candidates who did not meet the By-Laws requirements of serving on a team of at least one Cursillo Weekend and in addition disqualify applicants who did not submit their applications by the deadline. The deadline for submission of applications was May 14, 2022. This would disqualify, Garrison (not having served on a team), Lisa (not having served on a team, and late submission), and John (late submission) for Post Cursillo. We could then

vote in August after all the qualifications have been met. The motion was seconded by Wendy Voght. After a discussion, the motion made by Dave Marrazzo was voted down 6 to 1.

- Roberta Davis offered a motion to make an exception for a vote for the Bylaws requirement to having worked on a team for Chairperson eligibility, since the past 2 years have had extraordinary events. Lay Director Roseann Guerrini said this was not necessary. The motion was removed.

- Dan Brown was appointed to Chair of the School of Leaders by 6 votes in favor, and 1 abstain.
- Lisa Rowe was appointed Chair of the Post Cursillo Committee with 5 votes 2 went to other nominees.
- Next Secretariate meeting will be Tuesday, July 5 2022, .at Diocese of Harrisburg Conference Center. Mass will be held at 5:30 to start off our new year.
